"ChemCor is an ideal complement to our position in the wax additives business, which was previously occupied, especially in Europe, by BYK-Cera and has now been significantly strengthened beyond the region. Strategically we are very well placed to offer our wax additive customers a high level of innovative strength and service."

Dr. Christoph Schlünken, President Division BYK Additives & Instruments, is of the view: "The product portfolio of ChemCor does not just open up the American market in the area of wax additives alone; for BYK, new market segments, such as wax additives for industrial applications, also become accessible. What's more, the ChemCor site in Chester can also continue to grow through our know-how and our customer base locally."
