### **Vestas receives 24 MW order for Hungary**

Vestas has received an order for delivery of 12 x V90-2.0 MW wind turbines for the region of Böny in Hungary. The order has been received from the Hungarian company EURO GREEN ENERGY Fejlesztő és Szolgáltató Kft. and the contract includes delivery, installation and commissioning of the turbines, a VestasOnline® Business SCADA solution as well as a three-year service agreement.

The installation of the turbines in Böny, about 80 km west of Budapest, will start during the fourth quarter of 2009. The project is expected to be completed by the end of 2009.

Under the aegis of Mr Lendvay as Managing Director of EURO GREEN ENERGY and several of its subsidiaries, they have established four wind parks with a total of 11 wind turbines in operation in Hungary - all of them Vestas turbines.
