Furthermore, they suggest a holistic, lifecycle model is required with over half believing that governance should be implemented before the first service is created.

It brings structure, scale, and speed to SOA adoption by guiding reuse, automating SOA management processes, simplifying interdependencies and related complexities, and managing the entire service lifecycle.
