The operational objective of the new South African company is the planning and construction of industrial energy supply facilities in Africa. The main interest of the 100 % AGO subsidiary is the market development for trigeneration and energy efficiency projects for the medium-sized industry. AGO energy (Pty) Ltd. is planning the realization of energy projects with a total volume up to EUR 5.0 millions.

The main operation focus of AGO energy (Pty) Ltd. is the identification of potential projects. Besides Africa we keep an eye on further target countries and do check the ruling market potentials", says Hans Ulrich Gruber, CFO of AGO AG Energie + Anlagen.
